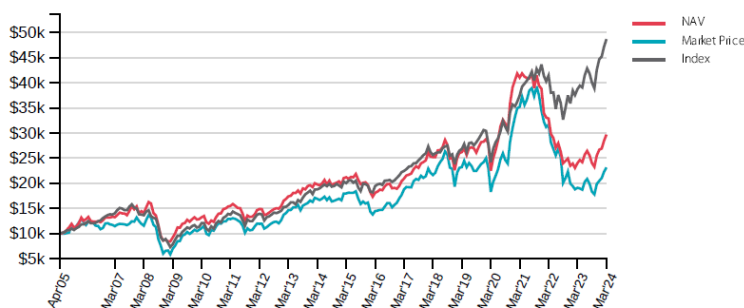

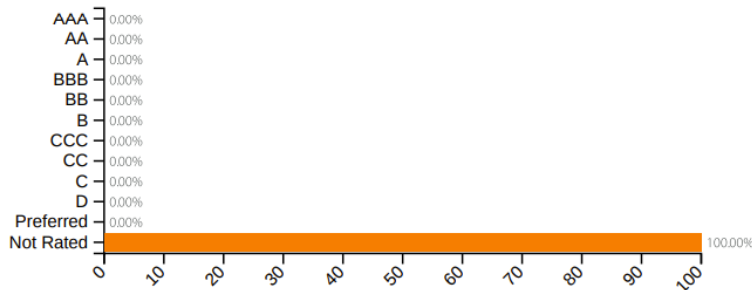

Bond Credit Ratings⁹
