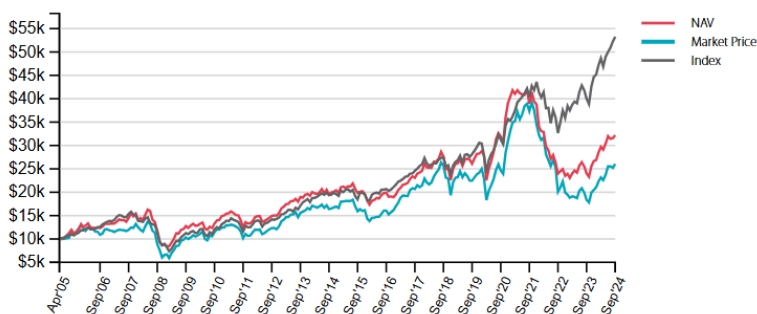

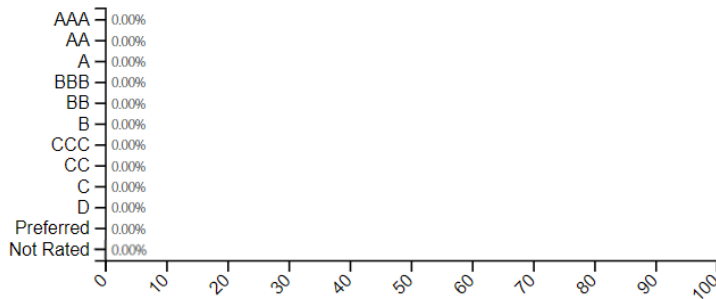

Bond Credit Ratings⁹

The Clough Global Equity Fund is a closed-end fund, which is traded on the New York Stock Exchange AMEX, and does not continuously issue shares for sale as open-end mutual funds do. The market price of a closed-end fund is based on the market's value.
