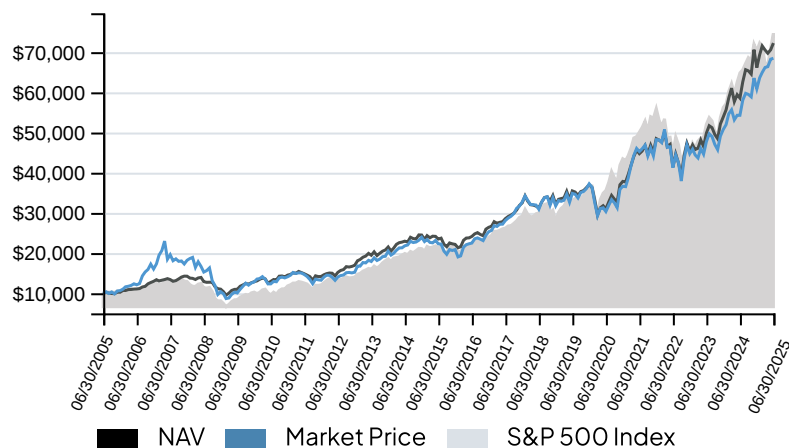

Distributions are paid from ordinary income; net realized short-term capital gains; net realized longterm capital gains; and return of capital, or some combination of the aforementioned. A return of capital may occur for example, when some or all of the money that you invested in the Fund is paid back to investors. A return of capital distribution does not necessarily reflect the Fund's investment performance and should not be confused with 'yield' or 'income.' Based on current estimates, we anticipate the most recent distribution has been paid from ordinary income, short-term capital gains; long-term capital gains; and a return of capital.
