

The fund seeks to pursue this objective by applying a fundamental research-driven investment process and will, under normal circumstances, invest at least 80% of its net assets, including any borrowings for investment purposes, in equity securities in both U.S. and non-U.S. markets.

The Clough Global Equity Fund is a closed-end fund, which is traded on the New York Stock Exchange AMEX, and does not continuously issue shares for sale as open-end mutual funds do. The market price of a closed-end fund is based on the market's value. The net asset value (NAV) of a closed-end fund is the market value of the underlying investments (i.e., stocks and bonds) in the fund's portfolio, minus liabilities, divided by the total number of fund shares outstanding. However, the fund also has a market price, the value at which it trades on an exchange. This market price can be more or less than its NAV. The fund's distribution policy may, under certain circumstances, have certain adverses consequences to the fund and its shareholders because it may result in a return of capital resulting in less of a shareholder's assets being invested in the fund and, over time, increase the fund's expense ratio.

The second, investment style risk, is the risk that returns from REITs—which typically are small or medium capitalization stocks—will trail returns from the overall stock market. The third, interest rate risk, is the risk that changes in interest rates may hurt real estate values or make REIT shares less attractive than other income producing investments. Interest rate risk is the risk that preferred stocks paying fixed dividend rates and fixed-rate debt securities generally will fall.
